## AN ORDINANCE TO AMEND ORDINANCE 2012-O-06 TO FUND MORE SURVEYING AND FEASIBILITY STUDIES FOR THE CMAQ 2&3 CAPITAL PROJECT ORDINANCE

**BE IT ORDAINED** by the Board of Commissioners of the City of Creedmoor that, pursuant to NC General Statutes Chapter §159-13.2, the following capital project ordinance is adopted:

- Section 1. The project being amended is the construction of a system of greenways and sidewalks, providing for east/west pedestrian activities, financed by a federal grant and Creedmoor reserves, commonly known as the "CMAQ 2&3" project.
- Section 2. The following amount is added to the appropriation for the project: \$28,500
- Section 3. The appropriation amounts for the project are amended as follows (Acct# 11-8000-4841 & 11-8000-4842):


