RESOLUTION 2017-R-18

INITIAL SCHEDULING RESOLUTION FOR

ZTA-2017-02, AN ORDINANCE TO AMEND THE CREEDMOOR DEVELOPMENT ORDINANCE ARTICLE 3 AND ARTICLE 7 TO CLARIFY THE PROCESS FOR ALLOCATING WATER AND WASTEWATER CAPACITY TO DEVELOPMENT

WHEREAS, the Planning and Community Development Department has realized a valid need to amend the text of the City of Creedmoor Development Ordinance in order to promote controlled, orderly development within the City and to preserve the general health, safety and welfare of the citizens of the City of Creedmoor; and

WHEREAS, the Planning staff has assigned the case number ZTA-2017-02; and

WHEREAS, ZTA-2017-02 proposes to amend the following articles of the Creedmoor Development Ordinance and various sections within:

ARTICLE 3: Definitions

ARTICLE 7: Permits and Procedures

WHEREAS, Article 5 of the Creedmoor Development Ordinance (CDO) states precisely how amendments to the development ordinance should be processed; and according to §5.3 Amendment Process of the CDO, this request does not require compliance with design guidelines at this stage and therefore does not require a recommendation from the Creedmoor Technical Review Committee; and

WHEREAS, ZTA-2017-02 will require a recommendation and a Statement of Consistency with City Plan 2030 from the City of Creedmoor Planning Board; and

WHEREAS, any recommendation made by the Planning Board to the Board of Commissioners shall be in writing and shall include a statement describing whether the proposed amendment is consistent with the comprehensive plan that has been adopted by the City and any other officially adopted plan that is applicable. A comment by the Planning Board that a proposed amendment is inconsistent with the City's land use plan, comprehensive plan or any other adopted plan for the area affected shall not preclude

consideration of approval of the proposed amendment by the City Board of Commissioners; and

WHEREAS, the City of Creedmoor Board of Commissioners intends to act on this amendment request and provide a decision according to procedure in the shortest reasonable time.

NOW THEREFORE BE IT RESOLVED by the City of Creedmoor Board of Commissioners that they do hereby:


- 1) Recognize ZTA-2017-02 as a proposed zoning text amendment;
- 2) Direct the Planning Board of the City of Creedmoor to make a recommendation on said proposed amendment and adopt a Statement of Consistency;
- 3) Set the date of the public hearing on ZTA-2017-02 for Tuesday, June 20, 2017 at 7:00 PM in the Board of Commissioners Meeting Room at City Hall, 111 Masonic Street, Creedmoor, NC; and
- 4) Authorize the City Clerk to publish legal public notice of the public hearing in the Butner-Creedmoor News in the June 8 and June 15, 2017, editions; and
- 5) Require that the City Clerk certify to the Board of Commissioners that proper notice has been given.
