RESOLUTION 2017-R-27

ADOPTING A COMPREHENSIVE TRANSPORTATION PLAN FOR GRANVILLE COUNTY, NORTH CAROLINA

The following resolution was offered by Commissioner Anderson, seconded by Mayor Pro Tem Wilkins and, upon being put to a vote, was carried 4-0 on the 6th day of November, 2017.

WHEREAS, the Town of Stem, City of Oxford, Town of Stovall, City of Creedmoor, Town of Butner, Granville County, the Capital Area Metropolitan Planning Organization (MPO), the Kerr-Tar Rural Planning Organization (RPO), and the Transportation Planning Branch, North Carolina Department of Transportation, have actively worked to develop a Comprehensive Transportation Plan (CTP) for the Granville County; and

WHEREAS, after completion and analysis of the CTP, the plan shall be adopted by both the governing body of the municipality or MPO and the Department of Transportation as the basis for future transportation improvements in and around the municipality or within the MPO as directed by North Carolina General Statutes §136-66.2; and

WHEREAS, the Capital Area MPO shall incorporate the adopted Granville County CTP into its Metropolitan Transportation Plan (MTP) for the portions of Granville County that are within the MPO jurisdiction; and

WHEREAS, it is recognized that the proper movement of traffic within and through the City of Creedmoor is a highly desirable element of the comprehensive plan for the orderly growth and development of the City; and the CTP may include projects in its transportation plan that are not included in a financially constrained plan or are anticipated to be needed beyond the horizon year; and

NOW THEREFORE, BE IT RESOLVED: That the City of Creedmoor Board of Commissioners hereby adopt the portion of the Granville County Comprehensive Transportation Plan dated August 2, 2017, that is within its planning jurisdiction, and endorses the portion remaining throughout Granville County, outside the City's planning jurisdiction. This plan should be approved and adopted as a guide in the development of the transportation system in Granville County and the same is hereby recommended to the North Carolina Department of Transportation, the Capital Area Metropolitan Planning Organization and the Kerr-Tar Rural


